

## Workaround for certain Northern Ireland Location of Goods Codes being used with Additional Information Codes NIDOM & NIIMP

Validation was added to CDS on 14<sup>th</sup> June 2025 to restrict the use of Additional Information Codes NIDOM & NIIMP to declarations on which the Location of Goods code declared in DE 5/23, is a recognised Northern Ireland location. Unfortunately, a small number of Northern Ireland Location of Goods codes have erroneously been omitted from this validation and cannot currently be used on import declarations. The locations impacted are –

We are working to resolve this issue but it is likely to take some time to deliver the correct functionality. In the meantime, import declarations which would otherwise be declaring one of the above Location of Goods codes, should use the most appropriate of the following as a workaround –

- If the operator has another site in Northern Ireland with a Location of Goods code not listed above, then that code can be used temporarily.
- If the location handles mainly maritime freight, then the Location of Goods code GBAUBELBELBEL can be used temporarily.
- If the location handles mainly airfreight, then the Location of Goods code GBAUBELBFSBEL can be used temporarily.

This issue does not impact on declarations using an authorisation or Customs Warehouse ID as the Location of Goods code e.g. goods being discharged from Inward Processing or being removed from a Customs Warehouse in Northern Ireland.
