1	New Additional Information (AI) Codes	Imports	<p>AI Codes 'MODRG', and 'SHORT' have been added to the CDS Code List.</p> <p>Please see Appendix 4B for Completion Instructions for declaring these AI Codes in Data Element (DE) 2/2</p>
2	Authorisation by Customs Declaration	Imports	<p>When entering goods to a Special Procedure using Authorisation by Customs Declaration and AI Code 'ABDIN' is declared in DE 2/2, DE 3/40 must not be completed.</p> <p>This implements a Policy decision that deposits of VAT as security for Authorisation by Customs Declaration are not permitted to be accounted for by use of Postponed VAT Accounting.</p>
3	Document Codes for cultural goods	All	<p>Document Codes 'L049', 'L050', 'L065', 'Y138', 'Y185', 'Y186' and 'Y235' have been added to the CDS Code List for use when importing cultural goods into Northern Ireland (NI).</p> <p>These document codes are currently visible in the NI Tariff and will come into force for declarations from the 28<sup>th</sup> June 2025.</p> <ul style="list-style-type: none"><li>Document Codes 'L049', 'L050', and 'L065' mandate the completion of the Document ID field.</li><li>Document Codes 'Y138', 'Y185', 'Y186', and 'Y235' mandate the completion of the Document Reason field.</li></ul> <p>If the correct field is not completed when declaring these Document Codes, the declaration will be rejected.</p> <p>Appendix 5A will be updated with these Document Codes before they are required by the NI Tariff.</p>

4	Northern Ireland Phytosanitary Goods	Imports	<p>When importing phytosanitary goods into NI and either of AI Codes 'NIDOM' or 'NIIMP' are declared in DE 2/2, and either of Document Codes 'N002' or 'N851' are declared in DE 2/3, Document Code 'C085' must also be declared in DE 2/3.</p> <p>If either of 'N002' or 'N851' are declared in DE 2/3 of a declaration where either of 'NIDOM' or 'NIIMP' are also declared in DE 2/2, and 'C085' is not declared in DE 2/3, the declaration will be rejected.</p> <p>'C085' must still be declared with 'N002' or 'N851', even if an X-series Status Code has been declared.</p>
5	Document Codes	All	<p>Further validation has been added for several document codes. 7	Export declarations	Exports	<p>Some declarations were being submitted that included Import Requested Procedure Codes on Export declarations. Validation has been introduced to stop this occurring in the future.</p> <p>When making an Export declaration, only Export Requested Procedure Codes can be declared in DE 1/10. If an Import Requested Procedure Code is declared in DE 1/10 on an Export declaration, the declaration will be rejected.</p>
8	Goods Location Code amendments	All	<p>New Goods Location Codes have been added to the CDS Code List.</p> <p>Appendix 16 will be updated with the details of these GLCs ASAP after the release.</p>
